## Grant Acronyms & FY23 Funding

- **PADD:** Protection and Advocacy for Individuals with Developmental Disabilities
  - \$414,977+ FY2023 grant + \$108,147 carryover = **\$523,124** Total
- PAIMI: Protection and Advocacy for Individuals with Mental Illness
  - \$473,700 FY2023 grant + \$222,013 carryover = **\$695,713** Total
- PAIR: Protection and Advocacy for Individual Rights
  - \$195,895 FY2023 grant + \$70,746 carryover = \$266,641 Total
- PABSS: Protection and Advocacy for Beneficiaries of Social Security
  - \$120,000 FY2023 grant + \$53,297 carryover = **\$173,297** Total
- **PATBI:** Protection and Advocacy for Individuals with Traumatic Brain Injury
  - \$50,000 FY2023 grant + \$16,683 carryover = \$66,683 Total
- PAVA: Protection and Advocacy for Voting Access
  \$141,043 FY2023 grant + \$192,748 carryover = \$333,791 Total
- PAAT: Protection and Advocacy Assistive Technology
  - \$43,750 FY2023 sub-award = **\$43,750** Total
- **PABRP:** Rep Payee: Strengthening Protections for Social Security Beneficiaries
  - \$265,680 FY2024 grant + \$31,898 carryover = **\$297,578** Total (Aug Jul Fiscal Year)
- WIPA: Work Incentives Planning Assistance
  - \$276,700 FY2024 grant + \$18,248 carryover = \$294,948 Total (Jul Jun Fiscal Year)
- PAPH: Protection and Advocacy for Expanding the Public Health Workforce
  \$110,318 Total (1 time grant with runway through 9/30/2024)

### Notes on Increases:

DRI received final award amounts for ACL and Dept. of Ed grants in February 2023. The grants with amounts in green increased in FY23.

Increases in funding for FY24 are no longer expected except in Rep Payee and possibly PAIR.

WIPA and Rep Payee are in their FY24 grant years due to the timing of their fiscal years.

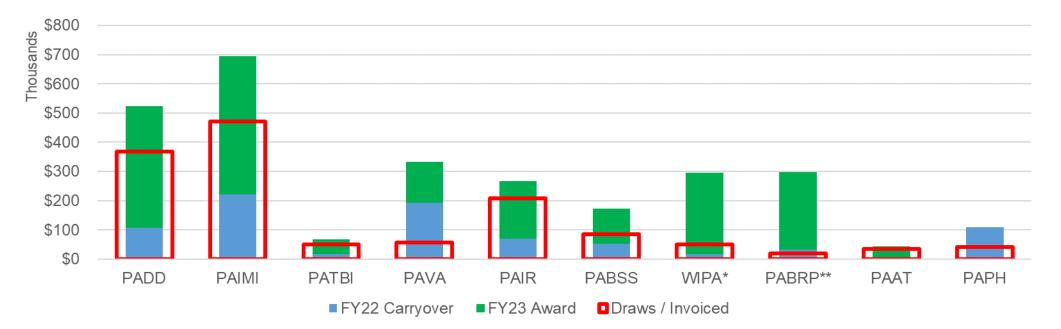

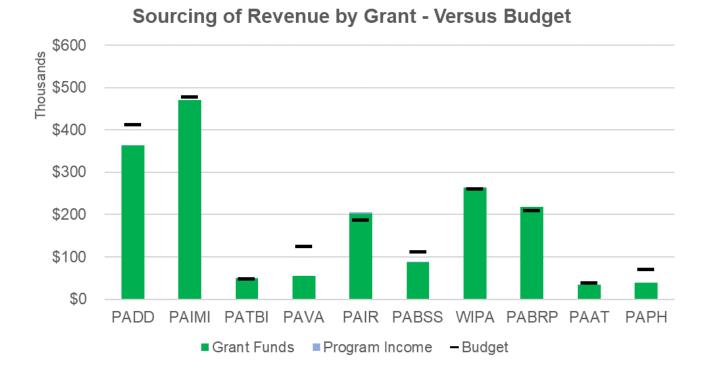

• Total Accrual Revenue through 8/31/2023 is \$1.82 million vs. budget of \$1.96 million.



### <u>Notes</u>

- Activity– PAVA and PAPH spending has been lower than anticipated. Other grant activity has been as expected considering employee vacancies. Including planned position filling decisions.
- **General** Lower spending in PADD in FY23 allows for a stronger budget outlook in FY24 and beyond.

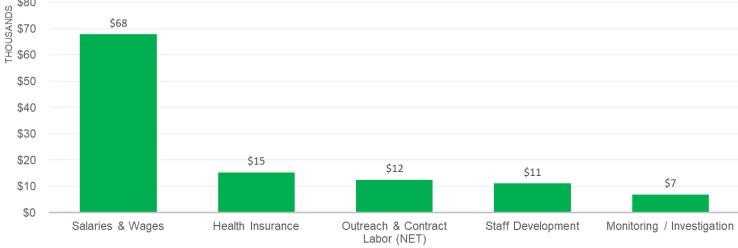
• Total Accrual Expense through 8/31/2023 is \$1.87 million vs. budget of \$2.02 million.

#### Notes

- Salaries & Wages Vacancies mentioned in ٠ previous slide. This variance has decreased since last Board Meeting.
- Health Insurance Among the most difficult ٠ items to budget, DRI takes a conservative approach. This combined with staff vacancies and elections, or lack thereof, of new employees has led to a positive variance.
- **Outreach/Presentations & Contract Labor** ٠ - This is the NET of these two line-items. Outreach events were trimmed to allow for N. Wilker's strategic plan consulting. PAVA outreach will be picking up in early FY24.
- **Staff Development** This line item is less ٠ favorable compared to last meeting due to sending four employees to NDRN's annual conference.

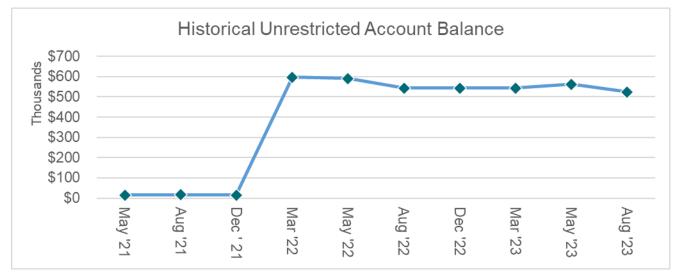
