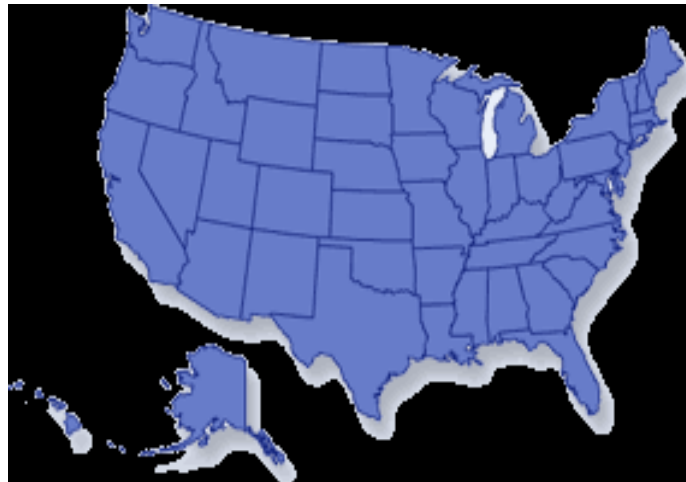

Willowbrook Scandal→

Congress established the protection and advocacy system for individuals with developmental disabilities

Other Scandals →

System to Protect & Advocate Grew

- Senate investigation into psychiatric facilities (1986) → Protection and Advocacy for Individuals with Mental Illness Program (SAMHSA, HHS)
- Presidential Election (2000) → Protection and Advocacy for Voting Access (Help America Vote Act, Adm. on Community Living, HHS)
- Henry's Turkey Farm, Atalissa, IA → Representative Payee Program (Social Security Administration)

Current DRI Programs (federally funded)

- P&A for Individuals with Developmental Disabilities, including intellectual disabilities
- P&A for Individuals with Mental Illness
- P&A for Individuals with Traumatic Brain Inj.

Authority

P&A is an “agent of the federal government, suing to assure the state’s compliance with the federal duties of care for [individuals with mental illness] that the state agreed to perform.”

Indiana Protection and Advocacy Services v. Indiana Family and Social Services Administration, (7th Cir. April 22, 2010) (J. Posner, concurrence)

Federal Statutes: Authority of P&As

1) Quasi-Investigation Agency:

Investigate incidents of abuse and neglect of individuals with disabilities if P&A receives

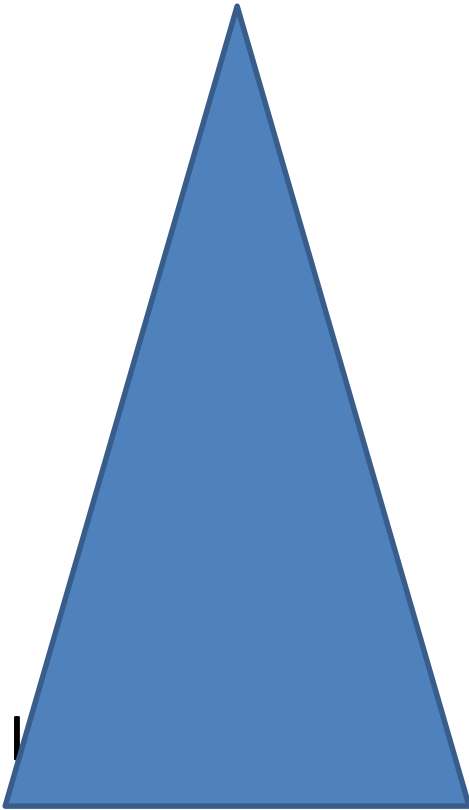
- Complaint
- P&A Determines Probable Cause of Abuse & Neglect

Federal Statutes: Authority of P&As

2) Representation: Pursue relief on behalf of individuals with disabilities

- Legal (individual or class action)
- Administrative
- Advocacy
- Negotiation
- Other

Americans with Disabilities Act, as amended



- Definition of “disability” broadened in 2008
- ADA prohibits disability-based discrimination
 - in employment (ADA Title I)
 - by state and local governments (ADA Title II)
 - public accommodations (ADA Title III)
